

ORDINANCE 2015-006

A ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; MODIFYING §39.29 OF CITY CODE, COOPERATIVE PURCHASING, AUTHORIZING THE CITY TO ENTER INTO COOPERATIVE PURCHASING AGREEMENTS AT THE DISCRETION OF THE CHIEF PROCUREMENT OFFICER AND IN ACCORDANCE WITH THE STATE PROCUREMENT CODE; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, the City of Sierra Vista is involved in the procurement of goods and services; and

WHEREAS, government entities desire to conserve resources and reduce procurement costs; and

WHEREAS, other agencies have current contracts for goods and services which satisfies state and local procurement requirements; and

WHEREAS, modifying City Code to allow the City of Sierra Vista to purchase goods and services utilizing other agencies' contracts while allowing other agencies to procure goods and services from City of Sierra Vista contracts when cooperative language is present within the contracts and cooperative agreements are executed with other government agencies; and

WHEREAS, entering into such cooperative agreements is permitted by Article 10, § 41-2632 et seq. of the Arizona Procurement Code; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

That the settled policy of the City Council supporting the use of cooperative purchasing agreements when it is in the best interest of the City of Sierra Vista, be, and hereby is, reaffirmed.

SECTION 2


That the City Council hereby approves an amendment to City Code §39.29, Cooperative Purchasing, replacing the section with the following language:

Pursuant to Article 10, §41-2632 et seq., Arizona Procurement Code, the city may participate in, sponsor, conduct, or administer a cooperative purchasing agreement for the procurement of any materials, services, or construction with one or more public procurement units in accordance with an agreement entered into between the parties.


SECTION 3
