

RESOLUTION 2015-047

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; REAFFIRMING SETTLED POLICY BY RECOMMENDING APPROVAL FOR AN INTERIM PERMIT, PERSON TRANSFER, CORPORATION-TYPE OF OWNERSHIP FOR A SERIES 6 LIQUOR LICENSE FOR CHARLES GEWLAS ON BEHALF OF CASTLE AND COOKE ARIZONA, INC. DBA PUEBLO DEL SOL COUNTRY CLUB; TO THE STATE DEPARTMENT OF LIQUOR LICENSES AND CONTROL; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, an application for an interim permit, person transfer, corporation type of ownership for a Series 6 Liquor License for Charles Gewlas on behalf of Castle and Cooke Arizona, Inc. dba Pueblo Del Sol Country Club, has been filed with the Arizona Department of Liquor Licenses and Control; and

WHEREAS, Arizona Revised Statutes §4-112 requires local municipalities to grant approval or disapproval of all liquor licenses being applied for within their jurisdiction; and

WHEREAS, the application has been posted on the premises of the business for twenty (20) days as required by State law; and

WHEREAS, it is the settled policy of the City Council that liquor licenses be recommended for approval if no objections are raised.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

The City Council reaffirms its settled policy on liquor licenses within City limits.

SECTION 2

The City Council of the City of Sierra Vista recommends approval of the application for an interim permit, person transfer, corporation-type of ownership for a Series 6 Liquor License for Charles Gewlas on behalf of Castle and Cooke Arizona, Inc. dba Pueblo Del Sol Country Club, to the State Department of Liquor Licenses and Control.

SECTION 3

The City Manager, City Clerk, City Attorney, or their duly authorized officers and agents, are hereby authorized and directed to take all steps necessary to carry out the purposes and intent of this Resolution.






