

RESOLUTION 15-062

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; REAFFIRMING SETTLED POLICY ON BOARDS AND COMMISSIONS BY REAPPOINTING DAVID GRIESHOP AND APPOINTING JOHN BARTON, PATRICIA OLSON, AND DAVID THOMPSON TO THE SIERRA VISTA PLANNING AND ZONING COMMISSION, SAID TERMS TO EXPIRE JUNE 30, 2017; AND ACCEPTING THE RESIGNATIONS OF JOE KRAPS, SHARON LAKE, AND BRUCE PIEPHO WITH REGRET, AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, the City Council has established the Sierra Vista Planning and Zoning Commission by resolution; and

WHEREAS, there are current Commission vacancies that exist; and

WHEREAS, it is the reaffirmation of settled policy that the City Council fill vacancies on boards and commissions.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, THAT:

SECTION 1

The City Council reaffirms its settled policy on appointments to boards and commissions.


SECTION 2

SECTION 3




