

RESOLUTION 2015-090

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; ACCEPTING THE APPOINTMENT OF DARNELL RAMBERT, SAID TERM TO EXPIRE OCTOBER 12, 2016 AND RE-APPOINTMENT OF FELICIA TUCKER, GEORGE POHLMAN, AND FRANK JACKSON TO THE AIRPORT COMMISSION, SAID TERMS TO EXPIRE OCTOBER 12, 2017 TO THE AIRPORT COMMISSION, AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, City Council has created an Airport Commission to provide public input and citizen participation on the policies and procedures that affect the operation and use of the Sierra Vista Municipal Airport, and to promote the growth and expansion of Airport services to the general public; and

WHEREAS, Darnell Rambert is available for appointment and Felicia Tucker, George Pohlman, and Frank Jackson are available for reappointment to the Airport Commission, and

WHEREAS, it is in the best interest of the City that this Commission continues to function with a full body of members.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

That the Council policy of filling vacancies on boards and commissions when qualified applicants are available, most recently affirmed be, and hereby is, reaffirmed.


SECTION 2

SECTION 3


