A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; REAFFIRMING THE CITY COUNCIL'S SETTLED POLICY ON BOARDS AND COMMISSIONS; REAPPOINTING KRISTOPHER RANGEL AND SUMMER MOREFIELD, TO THE COMMISSION ON DISABILITY ISSUES, SAID TERMS TO EXPIRE SEPTEMBER 22, 2017; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.
