

RESOLUTION 2015-111

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; RECOGNIZING THE CONTRIBUTIONS OF RICHARD "DICK" MCCOLLEY TO THE BETTERMENT OF THE SIERRA VISTA MUNICIPAL AIRPORT, NAMING THE AIRPORT LOUNGE IN HIS HONOR AND MEMORY; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, the Sierra Vista Municipal Airport (Airport) supports an array of aviation-related activities ranging from single-engine aircraft to corporate jets and unmanned aerial systems; and

WHEREAS, the Airport hosts an average of 300 operations per day, including general aviation comprised of locally based corporate, transient and student instructional traffic; and

WHEREAS, Dick McColley served as a member of the Airport Commission longer than any other member and held the positions of Secretary and Chairman; and

WHEREAS, under Dick McColley's leadership, the pilot's lounge was created to provide an area for flight planning, ground training, and to provide pilots, crews, families and students an area to network and socialize;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

That the Pilot's Lounge located at the Airport be named the Dick McColley Pilot Lounge.


SECTION 2

**SECTION 3**




