

RESOLUTION 2016-006

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; RECOMMENDING APPROVAL FOR AN EXTENSION OF PREMISES/PATIO PERMITS FOR A SPECIAL EVENT ON APRIL 2, 2016 FOR JERALD JAY REUTEBUCH FOR PC'S LOUNGE, 4700 EAST HIGHWAY 90, SIERRA VISTA, AZ; TO THE STATE DEPARTMENT OF LIQUOR LICENSES AND CONTROL; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, application for an extension of premises/patio permits for a special event on April 2, 2016 for Jerald Jay Reutebuch for PC's Lounge, 4700 Highway 90, Sierra Vista, Arizona, has been filed; and

WHEREAS, Section 4-203.02 of the Arizona Revised Statutes requires approval of the Sierra Vista City Council before the permit will be considered; and

WHEREAS, it is the settled policy of the City Council that applications relating to liquor licenses be recommended for approval if no objections are raised.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

The City Council reaffirms its settled policy, most recently affirmed on liquor licenses within City limits.


SECTION 2


