

RESOLUTION 2016-015

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; TO IDENTIFY PROJECT/PROGRAMS FOR THE 2016 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROJECT(S) AND OPEN THE 30-DAY REVIEW OF THE DRAFT ANNUAL ACTION PLAN IN ORDER TO COMPLETE THE HUD REQUIRED PROCESS PRIOR TO COUNCIL'S FINAL APPROVAL OF SIERRA VISTA ANNUAL ACTION PLAN.

WHEREAS, the City of Sierra Vista is eligible to obtain Community Development Block Grant (CDBG) funding directly from the Department of Housing and Urban Development (HUD); and

WHEREAS, HUD requires that participating jurisdictions prepare an Annual Action Plan in order to fulfill the HUD requirements for using the funding;

WHEREAS, the project to be completed with CDBG funding must be identified as part of the 2016 Annual Action Plan; and

WHEREAS, the City has several options from which to choose.

WHEREAS, the City plans to spend its 2016 CDBG funding on project(s) No. 1 A and B, 19 Street Lights in Fry Townsite in the Sulger Subdivision; No. 2, Roof of the Samaritan Station of the Good Neighbor Alliance; No. 3, Habitat for Humanity's *A Brush With Kindness* Critical (Emergency) Home Repair; and No. 4, Project Administration.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA AS FOLLOWS:

SECTION 1

That the City of Sierra Vista desires to obtain CDBG funding directly from HUD.

SECTION 2

That in order for the City of Sierra Vista to obtain CDBG funding from HUD, it is required to have an Annual Action Plan have identified project(s).


SECTION 3


