

RESOLUTION 2016-075

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, COCHISE COUNTY, ARIZONA; AFFIRMING ESTABLISHED POLICY; FINDING, DECLARING AND CERTIFYING THE OFFICIAL CANVASS OF THE PRIMARY ELECTION HELD ON AUGUST 30, 2016; AND AUTHORIZING AND DIRECTING THE CITY MANAGER, CITY CLERK, CITY ATTORNEY OR THEIR DULY AUTHORIZED OFFICERS AND AGENTS TO TAKE ALL STEPS NECESSARY TO CARRY OUT THE PURPOSES AND INTENT OF THIS RESOLUTION.

WHEREAS, the City of Sierra Vista held a Primary Election to three Council seats on August 30, 2016; and

WHEREAS, the City Council met in special session on September 12, 2016 to declare and adopt the results of the August 30, 2016 Primary Election; and

WHEREAS, the City Council has canvassed the votes of the Primary Election and have found the election was run and processed according to law and have determined the votes cast for each office.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SIERRA VISTA, ARIZONA, AS FOLLOWS:

SECTION 1

That the established policy relating to the canvassing of elections is hereby reaffirmed.

SECTION 2

The City Council of the City of Sierra Vista, Arizona does hereby find, declare and certify that the election results detailed in Exhibit "A" is the official canvass of the Primary Election held on August 30, 2016.

Of the four candidates running for the three open council positions, three (3) candidates achieved a majority. The candidates receiving a majority are Gwen Calhoun, Rachel Gray, and Kristine Wolfe. They will be seated effective January 1, 2017.

The City Clerk of the City of Sierra Vista is hereby directed to issue a certificate of election to the three candidates who received a majority of all votes cast in the Primary Election for the respective offices following the canvas of the November 8, 2016 General Election.

SECTION 3


